## POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 22 JUNE 2018

Reference is made to the circular of Shunfeng International Clean Energy Limited (the “**Company**”) dated 21 May 2018 (the “**Circular**”) and the notice of the AGM dated 21 May 2018 (the “**Notice**”). Unless otherwise defined, terms used in this announcement shall have the same meanings as those that were ascribed to them in the Circular.

### POLL RESULTS AT THE AGM

The Board announces that the AGM was held on 22 June 2018 at 11:00 a.m. The Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the AGM.

To the best knowledge of the Directors, no Shareholder has a material interest in the matters contemplated under the resolutions proposed at the AGM (the “**Resolutions**”) and thus no Shareholder was required to abstain from voting on any of the Resolutions in the AGM. Accordingly, as at the date of the AGM, the total number of Shares of the Company in issue, being the total number of Shares entitling the holders thereof to attend the AGM and vote on the Resolutions proposed at the AGM, was 4,314,151,191 Shares. There were no Shares entitling the Shareholders to attend the AGM but abstain from voting in favour of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. There were no restrictions on any Shareholders to cast votes on any of the Resolutions at the AGM. There were no parties that have stated their intention in the Circular to vote against or to abstain from voting on any Resolutions at the AGM.
